

## You Can Choose Where Your PA Tax Dollars Will Go (At No Cost To You!!!)

You already pay Pennsylvania State Taxes. Now you can choose to direct your PA tax money to St. Jude School to help offset tuition for students requiring financial aid. You can help a needy family obtain a Catholic education via **EITC** (Educational Improvement Tax Credit). This tax credit is available to many businesses and individuals.

The Foundation for Catholic Education will form a **SPE** (Special Purpose Entity) and apply to the state on our behalf.

### Individuals

Individuals who pay state taxes can participate and take full advantage of the PA EITC programs.

- Use the credit for your personal PA taxes
- 90% tax credit for a 2 year commitment
- Designate St. Jude School as your recipient

### Businesses

Businesses can contribute up to \$750K. C-Corps, S-Corps, LLC's and Limited Partnerships are eligible to participate.

- Available to those who do business in PA
- Receive a 90% credit for 2 year commitment
- Designate St. Jude School as your recipient

#### Redirect Your PENNSYLVANIA STATE tax dollars to St. Jude School in 4 easy steps

1. With your accountant, determine your tax liability and how much of your tax dollars you'd like to donate.
2. For individuals, fill out the simple application on the back of this flyer and return it to the school or church office. (For business donations, go to St. Jude School Website to download a Business Application.)
3. Once approved, contribute your PA tax amount to the scholarship organization within 60 days.
4. Submit paperwork provided by the state with your state and federal tax returns to receive your tax credit.
